### Care for the environment

We believe sustainability is imperative for the aviation industry. Our commitment to sustainability spans various initiatives from green airports and an energy-efficient product portfolio which enables customers to reduce their environmental impact, to our environmentally-friendly internal policies which promote sustainability, not just in our business operations but by spreading the message of 'green operations' among our employees and suppliers.

# Green airports with safe and efficient operations

Environmental sustainability is not just a buzzword at ADB Airfield Solutions. As an ISO 14001 certified company, our environmental policy, processes and systems to the frameworks of this globally recognized quality standard.

We have well-defined goals and systems and Key Performance Indicators, to effectively measure and improve environmental impact. These range from replacement of various energy-intensive systems to use of more efficient power sources, and improvement of waste management, among other things. This strongly reflects our sustainability philosophy, the primary goal of which is to reduce our carbon footprint.

With this in mind, we also help our customers pursue a 'green airport' strategy to minimize the environmental impact and costs of airfield operations. We create products and solutions that meet stringent energy-saving targets. Moreover, our latest generation products use components that are as individually-recyclable as possible. All this is achieved while conforming to the tightest safety requirements.

More sustainable airports depend on innovation in infrastructure such as airfield lighting. For example, ADB pioneered the use of LED technology in airfield lighting and offers some of the most energy-efficient power supply systems available. More than 800,000 ADB LED lights currently illuminate over 450 airports around the world, delivering not only substantial energy savings and reduced maintenance costs, but increased safety because fewer airport vehicles maintaining lighting reduces the risk of hazardous runway incursions.

As airports strive to increase capacity, they need to minimize runway and taxiway closures. At the same time, there can be no compromise on safety. This is why we developed AirSide Management which takes account of every aspect of maintenance critical to the safe functioning of all visual guidance on an airfield. This advanced preventative maintenance solution improves safety, limits airfield activity and reduces airfield downtime simultaneously.

## Sustainable business operations

ADB's policies, processes and systems align to achieve sustainable business operations which span:

 Responsible use of materials and waste management: We do not undertake any work that involves the use of hazardous substances such as acids, solvents, or heavy metals. We focus on responsible use and waste minimization, and ensure material waste following production



is recycled as per industry best practices. We apply ambitious Key Performance Indicators such as requiring that 90% of waste be recycled, and report this annually to measure and track progress.

- Use of renewable energy: ADB's corporate headquarters is powered entirely from renewable energy sources.
- Inspiring employees to think 'green': Annual awareness campaigns across ADB locations around the world help our employees to reduce their individual carbon footprint and contribute to ADB's environmental goals.
- 'Green' supply chain policy: ADB implements responsible procurement throughout its supply chain. The majority of our suppliers guarantee that no hazardous materials are used in the products they deliver and that their processes minimize material waste and environmental impact.

A strategic Quality Management (QM) framework that focuses on continuous improvement helps us deliver excellence in product, services and solutions. Our QM team oversees the quality of processes and products within ADB - it maintains an ISO: 9001 registered quality management system and ensures conformity at all stages from product design through servicing. All ADB product development follows strict product guidelines and rigorous processes. Our processes are audited regularly by internal auditors and independently by Bureau Veritas, a world leader in conformity assessment services. Furthermore, our employees are trained and equipped to pursue the continuous improvement of products and services.

ADB's Value - Fair, is all about respecting people. Our CSR Charter further outlines our commitment to our people.
